

## European banana market supplies

## Enough is enough!

Study of EU market supply shows that the symbolic 4 million tonne mark was exceeded in 2000 for banana consumption in Europe. It will be remembered that 2000 was a real catastrophe as far as prices were concerned.

We seem doomed to using superlatives when discussing the banana industry. The common market organisation of banana is not adapting but undergoing in-depth reform. Disputes are not settled by common agreement but turn into complaints to numerous courts and international negotiations never fail to become trials of strength. Examples abound.

The same atmosphere is felt in the supply of the EU market. The latter increases strongly each year, breaking records. The supply calculation for 2000, equivalent of theoretical consumption, gives the result of 4 million tonnes. This figure had often been approached but never attained and reflects strong pressure from ACP (especially Africa) and community

origins. In 2000, Cameroon and Côte d'Ivoire each shipped more than 200 000 tonnes. All the EU production regions did better than in 1999. The increase of shipments from dollar origins was more modest.

The very low prices reached on the European market in 2000 will be remembered. The increase in volumes was not unrelated to this poor situation. However, when the other explanatory factors are examined (distribution over the year, general fruit quality, the congestion of certain markets, etc.), it is difficult to believe that an extra 133 000 tonnes (+ 3 percent) caused the complete destabilisation of the European market. The effect of massive import fraud is not unrelated to this strong market degradation.

## ACP: a high risk phase 2

The 2000 figures for ACP show that they exceeded (by nearly 7 000 tonnes) the quota ceiling set by the agreement between the European Commission and the United States last April. The compromise plans the switch to a Phase 2 (starting date uncertain) in which the present C quota would be reduced by 100 000 tonnes but reserved for ACP suppliers alone (without distinction). Furthermore, the still partial information on 2001 performance and 2002 forecasts for ACP producers, especially in Africa, indicates a strengthening of this tendency to exceed the limit

- Eurostat data divided into (a) traditional quantities from traditional ACP states, i.e. within the limits of individual quantities (e.g. (2)155 000 tonnes for Côte d'Ivoire) and (b) non-traditional quantities from traditional ACP countries (e.g., for Côte d'Ivoire, exported quantities over and above the 155 000 tonnes allowed ) and from non-traditional ACP countries (Dominican Republic, Ghana, etc.).
- (3)Eurostat data: all imports from non-community and non-ACP countries.
- (4)Duty-paid bananas (released for free circulation) in one of the EU member countries and then exported outside EU-15. It is supposed that these are dollar bananas.

General note: Before 1994: dessert bananas + plantains / From 1994 onwards: dessert bananas. Before 1995: EU-12 / From 1995 onwards: EU-15. The study concerns extra-community import data for ACP and dollar bananas and re-export. The rules of operation of the common market organisation of banana (1993 version) have been applied to the data from 1988 onwards in order to give comparable results.
